Challenges... As we begin the new school year, students, teachers, and families face a myriad of challenges. Challenges like "summer learning loss" have increased and problems like "food insecurity" have been exacerbated. Now, more than ever, The Education Alliance is **working to mobilize business and community support to solve these challenges together**. This report highlights the amazing impact of our AmeriCorps Mentors who provided virtual mentoring and distributed more than 50,000 meals during the crisis (see Cover and page 3).

Opportunity... Before COVID, we had received 170 applications from high school students to participate in 4-week, onsite WV Ready Internships at ten businesses across the state. Thanks to the flexibility of our business partners, educators, and students we transitioned to an innovative **virtual model** of training, mentoring and capstone projects. The transition brought new opportunities and **increased access** for our most rural high school students to gain real-world experience through the virtual internships (see page 6).

Acts of courage and hope... In our first-ever Virtual EDTalk, West Virginia Teacher of the Year Jennifer Schwertfeger, shared a powerful story about acts of courage and hope that she witnessed among her students during the crisis. The Education Alliance is telling these stories because they inspire us to support a public education system that is strong and resilient well into the future.

MAKER SPACES JOIN EFFORT TO MAKE MEDICAL MASKS

Since 2014, The Education Alliance has helped schools expand Maker education through programs like our Blended Learning initiative that provides training, resources, and equipment. During the past school year, school Maker Spaces were part of a statewide effort including Career Technical Centers that made more than 60,000 pieces of personal protective equipment and donated them to West Virginia hospitals. Education Alliance AmeriCorps VISTA, Caleb Rusk (pictured here) was instrumental in supporting Lincoln County High School efforts to create 3D printed masks for medical professionals in the school's Maker Space.

VIRTUAL INTERNSHIPS TEACH REAL-WORLD SKILLS


In July 2020, fifteen high school juniors and seniors from across the state participated in a 4-week virtual internship program. WV Ready Interns developed career knowledge and skill sets to ensure they're ready for success after graduation. The Education Alliance paired each intern with business mentors from Dow Inc., Toyota Motor Manufacturing WV, and WV American Water. Interns participated virtually in high-quality training modules and worked in virtual teams to complete a capstone project to re-engineer an existing product or develop a new system that addressed a challenge from their host business.

NUMBERS AND STATISTICS


The Education Alliance is a research-based organization with a track record of datadriven decision making. Some of our historical benchmarking metrics were interrupted by COVID-19 as external evaluators were prohibited from collecting end of year achievement data. Resources provided to schools, such as program grants saw a significant decrease. However, other outcomes, such as the number of volunteers leveraged, remained robust in the crisis.

EQUIPPING STUDENTS FOR SUCCESS

The Education Alliance equips West Virginia students for success through education opportunities and support.

AmeriCorps Mentors: 32 AmeriCorps members provided a dropout prevention mentor-based intervention designed to improve student attendance, behavior, and course performance. Major funding provided by the Corporation for National & Community Service and Volunteer West Virginia with support from the Fenton Foundation, the Parkersburg Area Foundation, and the Greater Kanawha Valley Foundation.

Blended Learning: 7 rural schools received training and support to "blend" face-to-face instruction with online resources and hands-on-learning through Makerspaces. Funding provided by the BelleJAR Foundation, Claude Worthington Benedum Foundation, Chevron, and Ross Foundation.

Born Learning Academy: 9 elementary schools offered a series of six engaging academy sessions for families with young children designed to create teachable moments for their children. Major funding provided by Toyota Motor Manufacturing West Virginia.

College Ambassadors: 9 AmeriCorps members served at Community Colleges working to increase college access and enrollment. Major funding provided by the West Virginia Community and Technical College System and the Corporation for National & Community Service and Volunteer West Virginia.

Energizing steM: 2,200 elementary students in Lincoln and Logan counties received computer-based supplemental math curriculum (Imagine Learning) along with promoting community support for math education. Major funding provided by American Electric Power Foundation.

Financial Literacy: Statewide partnership that provided resources to help students make wise and informed financial choices. Major funding provided by the Higher Education Policy Commission.



MOBILIZING BUSINESS & COMMUNITY SUPPORT

The Education Alliance mobilizes business and community support for schools to improve student outcomes.

College Access: 35 middle schools received funding and technical support to engage students in college visits. Major funding provided by the Higher Education Policy Commission.

Partnerships in Education: 3 school and business partnerships received a communications package to promote their partnerships that produce WV Ready Graduates. Major funding provided by West Virginia Public Broadcasting.

WV Ready Internships: 15 high school students received a 4-week virtual summer internship experience with a West Virginia business. Major funding provided by Toyota Motor Manufacturing West Virginia and the Benedum Foundation in partnership with Dow Inc. and West Virginia American Water.

STEM VISTA: 7 Volunteer in Service to America (VISTA)'s built the organizational, administrative, and financial capacity of schools and nonprofit organizations to implement and enhance STEM education. Major funding provided by the Corporation for National and Community Service.

ADVANCING SYSTEM IMPROVEMENT

The Education Alliance advances the improvement of West Virginia's education system through research-based vision setting, dialogue and advocacy.

Research and Outreach: Throughout the 2020 legislative session, the Alliance worked to support systemic improvement by advancing key policy priorities such as HB 4519 Creating a Summer Youth Internship program, SB 750 Establishing Extended Learning Opportunities; and SB 839 Creating an Advisory Council on Post-secondary Attainment. The Alliance provided community members with up-to-date education news and policy information, as well as research on key issues.

WV Education Summit: In its seventh year, the statewide education summit engages businesses, community and education leaders in innovative dialogue and collaborative efforts to achieve excellence in education in West Virginia. Event sponsorship provided by Appalachian Power; AT&T; Bowles Rice; Dominion Energy; EQT; First Energy Foundation; Jackson Kelly; Mountain Health Network; Mylan; Northeast Natural Energy; United Bank; West Virginia's CLIMB; West Virginia Economic Development Council; West Virginia Public Broadcasting; and ZMM Architects & Engineers.

EDTalks: 2 regional events were held virtually to generate innovative discussions and big ideas about connecting education, jobs and West Virginia's future. Event sponsorship provided by Dow, Inc. and Bowles Rice LLP. 2020 Speakers include: US Senator Joe Manchin III, US Senator Shelley Moore Capito, State Superintendent of Schools Clayton Burch, West Virginia State Teacher of the Year Jennifer Swertzfeger (pictured on page 14) and other key leaders.



HELPING STUDENTS ENROLL IN COLLEGE

This year, The Education Alliance piloted a new program called College Ambassadors that engaged 9 local movers and shakers as AmeriCorps members to increase college access. The members served on community college campuses across the state and helped students complete the application and enrollment process. During the pilot project, College Ambassadors helped 175 high school seniors and adults apply for community college.
